"EMERGENCY CIRCULAR "

- 1. To prevent spread of CORONA VIRUS Disease (COVID-19) into Bangladesh through sea route, all ships arriving to Chittagong Port shall exercise following precautionary measures;
 - a. No officer/Crew shall be granted shore pass unless emergency and with prior approval of Port Health Officer.
 - b. Signed off Crew shall remain under Quarantine for a period of 14(Fourteen) days from the date of out pass from immigration gate (Gate No. 1) of Chittagong Port.
 - c. Any information of COVID symptomic patient on boardship shall be informed to Port Control Room (Tel No: 031726916) and to Port Health Officer immediately. In such case ship's movement/cargo operation will be subjected to report of PHO inspection.
- 2. This circular is published with the approval of competent authority.
