



This public notice for auction ("the notice") is hereby published in compliance with the order dated 31.01.2017 passed by the Honorable High Court Division of the Supreme Court of Bangladesh in Admiralty Suit No. 89/2016, directing the Chittagong Port Authority to invoke its power under the provision of section 24 of The Chittagong Port Ordinance, 1976 read with Regulation 122 of Regulations for working of the Chittagong Port (Cargo and Container), 2001.
2. In accordance with the above direction passed by the Honorable High Court Division on Admiralty Suit No. 89 of 2016, and for securing the national interest and clearing huge occupied premises, Chittagong Port Authority is hereby taking necessary steps as per the Chittagong Port Authority Ordinance, 1976 and Regulations for Working of Chittagong Port (Cargo and Container), 2001 to sell through public auction a total number of 1305 (One Thousand Three Hundred Five) empty containers of Twenty foot Equivalent Units (TEUs) equivalent to 654 boxes (types - 20' Flat Rack/Open top, 40' Dry/Flat Rack/Open top, 40' Reefer) belonging to the Hanjin Shipping Bangladesh Limited, which are now lying within the port premises.
3. **The main features of the auction Procedure are as follows:**
