





1. A bulkhead "MAGFERAT NOOR" has sunk at around 0845 hours on 31-01-2024 near buoy no 2 at river mouth in position LAT: 22°13'00.480"N, LONG: 091°47'34.455"E. Her sunken position is dangerous for surface navigation. Wreck position is marked with a Red buoy- FL R 2 Sec. after ev. 4 Sec.
